Smoke Detector Program

The August issue of the *Beacon* discussed a possible program in conjunction with the Forney Fire Department to assist and educate Travis Ranch homeowners to maintain their Smoke Detectors. A Survey Form was distributed with the *Beacon*. Since only 13 of the Survey Forms were received, and only four of them requested help with their smoke detectors, no further program is being implemented. The four help-requests are being turned over to the Forney Fire Department for follow-up action. Remember if your smoke detector goes off for no reason and you don't know what to do, you can call the Forney Fire Department (at 911.)



HOA Annual MeetingFails to Reach Quorum

The Travis Ranch Property Owners Association Annual Meeting was held at Lewis Elementary School on September 26. However, as it failed to achieve (even with Proxies) the required 10% for a quorum it was not an official meeting and thus had neither official minutes nor any votes on any issues. Danielle Lascalere, of Essex Management did however report on a number of items. These included damage to trees and bushes along the Boulevard, trespassing on the land beyond the end of the boulevard and other problems. She also reported that Travis Ranch was ultimately planned to include about 3200 home sites. There was interest in the longreported possible boat ramp on Lake Ray Hubbard. While possible in the future, no action is presently underway or anticipated. The residents present raised a number of serious issues and questions which, lacking minutes cannot be adequately reported. (Please see "Editorial")

An "Editorial"

Reported in this *Beacon* was the meeting which was to have been the required annual meeting of the HOA. The attendance required to constitute a quorum was only 10% (including proxies!), but far less showed up. Are so few of the residents of Travis Ranch sufficiently interested in their community to attend a meeting to voice their concerns and learn the issues affecting their community?

Regrettably, it had been announced only through individual official letter from the management group a couple weeks prior, but not in the previous issue of the *Beacon* or in other available media. Certainly those residents that did attend were quite vocal in pointing out problems relating to fences, street lights, dogs, empty lot maintenance, parked cars, trucks and boats, trespassing on adjacent lands, damage to common-area landscaping, prospective boat ramps, the hockey court, traffic on the boulevard and many others. So the problems are there and people are interested in solving them. We need to assert our rightful role, initially simply by attending the HOA meeting called to hear our concerns, and to take effective action to maintain and improve our community.

It is my promise to be aware of the next meeting date well ahead of time, and to actively promote it through every means available. Hopefully that won't have to be a full year from now.
